Eligibility

TO BE ELIGIBLE TO APPLY FOR U.S. CITIZENSHIP, YOU NEED TO:

- $\hfill\square$ Be at least 18 years old by the date you file.
- □ Have been a lawful permanent resident for at least the last 5 years (or 3 years, if married to a U.S. citizen).
- □ Have been present in the U.S. for 2.5 of the past 5 years (or 1.5 of the past 3, if married to a U.S. citizen).
- □ Be able to speak basic English. (YOU MAY QUALIFY FOR AN EXCEPTION.)

What to Bring

- □ Your Permanent Resident Card (Green Card).
- $\hfill\square$ Your most recent tax return and W-2 forms.
- □ Your current and all expired passports.
- $\hfill\square$ All documents you have about your immigration record.
- □ Filing fee varies by income level:

The full fee is \$725.

 If you plan to pay for the application yourself, you will need a check, cashier's check, or money order made out to "U.S. Department of Homeland Security."

You may qualify for a fee waiver or reduced fee.

To check your eligibility, you must bring the following:

- Proof of Department of Social and Health Services (DSHS) public benefits such as your award letter.
 OR
- Proof of your income, for example your most recent tax returns and pay stubs.

Additional Documents

YOU WILL NEED TO GATHER THE FOLLOWING INFORMATION:

- □ List of home addresses for the past 5 years and the dates during which you lived at these addresses.
- □ List of employer names and addresses for the past 5 years and the dates you worked with these employers.
- Dates you have been outside of the U.S. since becoming a permanent resident and the countries you traveled to during these trips.
- □ Your children's complete names, dates of birth, and their alien registration numbers if they have one.
- □ The names, dates of birth, dates of marriage, and dates of divorce for all current and past spouses.

YOU MAY ALSO NEED THESE ADDITIONAL DOCUMENTS:

- \square Marriage certificate(s).
- \Box Divorce decree(s).
- \Box Proof of having supported your dependents.
- □ Legal name change document, (if the name on your green card is different from your current legal name).
- □ If you are applying based on marriage to a U.S. citizen, bring proof of your spouse's U.S. citizenship, (for example, a passport, naturalization certificate, or U.S. birth certificate) and documents that prove you live together, (for example, a utilities bill listing both of you living at the residence).
- □ If you have ever been arrested or detained by any law enforcement officer for any reason, bring a Certificate of Disposition from the Criminal Court, a copy of the police report, and any other documents you have about the incident(s).
