

2024 TACOMA LATINO CHAMBER OF COMMERCE PUBLIC POLICY PLATFORM

The Seattle Latino Metropolitan Chamber of Commerce was founded on the notion that the success of the American economy is directly linked to the success of the Latino business community. In this context, since 2017, the SLMCC has been supporting the voice of Latino business owners in Greater Seattle, including King County. Now, continuing with the goal of still supporting and be the voice of the Latino community in USA, we create the Tacoma Latino Chamber of Commerce, where Latino entrepreneurs can be part of this great project that seeks to support and boost their businesses by granting them exclusive benefits.

The purpose of the 2024 TLCC Public Policy Platform is to summarize the positions of the Chamber on the most relevant public policy issues that impact Latino Businesses and the Latino community. In the United States, there are five million Hispanic-Latino owned business that, together, contribute over \$800 billion dollars to the US economy each year. Latino-Hispanics are starting businesses at three times the rate of the general population, and Hispanic-Latino women start businesses at six times the national rate. Overall, Hispanic-Latino power the economy with a \$2.8 trillion gross domestic product and comprise almost 19% of the American workforce.

Despite the economic contributions of the Hispanic-Latino community, their businesses face disproportionate barriers that create challenges to starting, running, capitalizing and scaling a business. If Hispanic-Latino businesses were given the opportunity to scale at the same level as non-minority-owned businesses, there would be an additional \$1.47 trillion contributed to the American economy, larger than the GDP of countries like Australia, Mexico, Spain and Saudi Arabia.

In this context, the Tacoma Latino Chamber of Commerce is committed to advance the interests of Latino-owned businesses in Washington State through our labor of advocacy that covers a wide range of policy issues that affect the economic prosperity of Latino businesses.

The mission of the Tacoma Latino Chamber of Commerce is to foster the economic growth that creates and sustains prosperity for the benefit of the Latin community. We know that when policy makers in Washington prioritize the rise of America's small and minority business communities, our country's wider economic outlook improves.

The vision of the Tacoma Latino Chamber of Commerce is to be the leading the voice to advance Latino businesses potential to drive our American economy.

The Tacoma Latino Chamber of Commerce seeks to promote the economic growth, development, and interests of its membership and all Latino-owned businesses.
